VISIONS OF CULLEN PARK UPDATES

Visions of Cullen Park was privileged to have the new Commissioner of Parks, Recreation and Forestry, Karen Ranney Wolkins and District 6 Councilman, Chris DeLaney at the July meeting. The idea was to become acquainted and share goals. They both expressed their interest in returning in the future.

The water level finally went down and the kayak docks were able to be installed. There has been concern about the boat launch docks being partially under water and being slippery to walk on. I spoke to Jeremy at Streets, Harbors and Bridges and he said it was being addressed.

After much discussion regarding a butterfly garden, it was mentioned that for all practical purposes, one does exist near the vernal ponds due to milkweed and other plants which attract butterflies. Several people have posted beautiful pictures including colorful flowers. There are other spots in the park doing the same.

Due to comments from park neighbors Police Chief Kral has ordered that issues regarding the light at the camera will be addressed and police crews will be watching for cars in the park after closing hours. "No Fishing" signs have been posted at the boat launch site due to anglers who interfere with boat traffic. With the fishing pier being available now there is no reason for this to be a problem.

Applications available for Point Place Art Walk

Artists are sought for the annual Point Place Art Walk on the Bay.

The outdoor fine arts exhibit runs along a public pathway on the east side of Summit Street, between the Point Place Lighthouse and the Pinkley Pathway.

The one-day show will be held Saturday, September 22, from 10 a.m. to 4 p.m., with a rain date of Sunday, September 23.

All media are welcomed to this juried show. Craft, bazaar and flea market items will not be accepted.

To be considered for a space in the show, artists must submit three, clear, non-returnable photos of recent and representative work for jurying. Alternately, a website with current examples of artwork may be submitted.

Work that is submitted for jurying must be the original creation of the artist and will be evaluated on the basis of originality, quality and appearance.

The deadline for applications is two weeks prior to the show. Space is limited.

Applicants will be notified of their acceptance by mail or email.

A non-refundable entrance fee of \$40 will be charged for

an approximate 15'x15' space. No payment should be sent until the artist has received an invitation to participate in the show.

Tables, chairs, tents, covers, etc. will be the responsibility of the artist.

There will be no electrical hook-ups, but public facilities along with food and beverage service will be available.
