The February Dinner Meeting will be on Wednesday, February 21st, 2024, at Friendship Park Community Center:

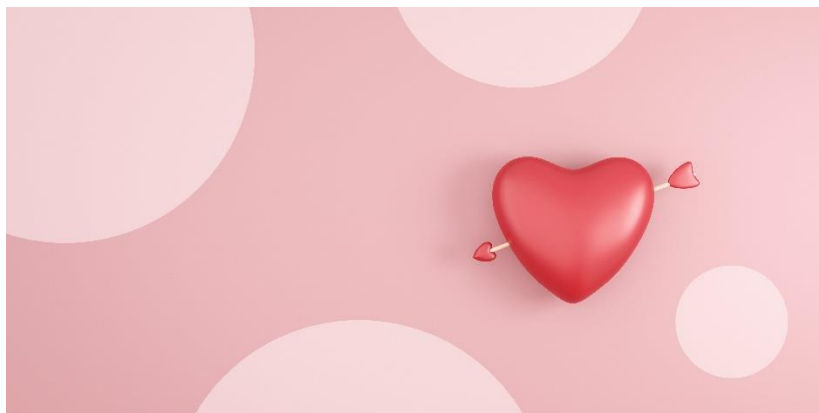
